There are NO REFUNDS on any deposits or payments. Failure of the Buyer to complete this purchase would subject the Seller to lost opportunities to sell the puppy to some other buyer, and retaining the deposit is meant to compensate seller for their possible loss. This deposit signifies the intent on the part of the Buyer to follow through with the purchase of this puppy. The Seller reserves the right to VOID transaction if we learn of any reason why Buyer may not be suitable home for the puppy-(i.e. Buyer is found to be an animal abuser, a violent person, representative of a pet store, pet broker, pet flipper, representative of a pharmaceutical research laboratory etc..) In the rare event of some tragic accident if the puppy were to pass away or otherwise be seriously injured while still in our care, Before it goes to its new home, THEN of course the deposit

would be returned to the Buyer or it can be applied to another puppy when available, whether it be from this litter or the next.

HEALTH GUARANTEE

The Breeder/Seller guarantees your puppy to be free from infectious diseases for 48 hours after the puppy leaves our premises and guarantees the puppy to be free from certain congenital genetic problems for up to 6 months of age. Hip, Elbow, Joint, and Patella problems can be caused by or influenced by overfeeding, improper diet, failure to maintain proper weight, accident, injury, overexposure to slippery surfaces, failure to provide sufficient exercise, jumping off tall furniture, overexertion or improper exercising which would be out of our control and considered environmental cause, and is not covered by our health guarantee. We do not guarantee or warranty that any puppy or dog will be a show prospect or show quality. We do not guarantee that a puppy will be able to breed or produce a litter/offspring once fully mature. We cannot and do not guarantee or warranty any dogs fertility. Our dogs have demonstrated great stable, kind, gentle temperaments. Our puppies are socialized and sound when delivered, however, we do not guarantee temperament. We take exceptional care to provide a secure, loving environment for our puppies starting from birth until they go to their new homes. After pickup or delivery, the responsibility is now on the Buyer to continue proper socializing and providing a good environment/ safe home for the puppy. It is the Buyers responsibility to keep the puppy free from harm and bad interactions with other people, dogs and animals. Any negative exposure of the puppy to bad experiences with other dogs or people can cause harm and lasting effects. The Buyer also agrees to fully vaccinate the puppy before public socialization. The Buyer agrees to watch for any signs of hypoglycemia which can occur to in small puppies under stress or changes. The buyer agrees to keep the puppy healthy, maintain and stay current with all puppy vaccinations, occasional deworming, provide periodic vet checks including an initial examination within the first 48 hours after delivery and to keep the pup at a healthy weight by feeding quality dog food. Your puppies health record will be provided with vaccination dates listed, please bring with you to your veterinarian. Breeder/seller will provide the Buyer with a puppy that is clean, in good general health, and that has no known physical defects. Deworming and a minimum of the first round of immunizations will be completed- will have dates on the vaccination record given upon delivery/pickup. Certain congenital/ genetic defects are covered by this guarantee for up to 6 months of age including blindness, pancreas, kidney, spine, lungs, and heart(Heart murmurs are NOT covered as they generally clear up with age). Seizures and or epilepsy is not covered as it can be caused by environmental conditions.

GENERAL

Puppy will not under any circumstances be placed in a dog pound, or a shelter, humane society, rescue center- Please contact us first if you find yourself in any circumstance where you are unable to care for your dog, if at all possible we will find a new loving suitable home for him/her.

This written agreement contains all the terms of this puppy purchase agreement NO REFUNDS will be given. ALL DEPOSITS, PAYMENTS , and or SHIPPING COSTS are non refundable. All sales are final by purchasing a puppy from Atkins Appleheads
